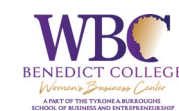

Ask for a courtesy inspection as far in advance as possible.

Be sure to familiarize yourself with regulatory requirements to avoid undoing costly mistakes.

NOTE: A business license will be issued after signatures are completed by the Fire Marshal, Building Official, Utility & Engineering, and in some cases DHEC, and SCDOR.

OFFICE OF BUSINESS OPPORTUNITIES

MISSION: The Office of Business Opportunities (OBO) is committed to supporting initiatives that benefit small, minority, and women owned businesses located in, or that want to do business with, the City of Columbia. This is accomplished by providing creative financing and funding, technical assistance, and the City's utilization of local, minority, and women owned businesses to ensure that our funds contribute to the economic growth of all communities.

COMMERCIAL RETENTION & REDEVELOPMENT PROGRAM

Provides financial assistance to start-up and existing businesses for expansion, creation, and retention of jobs, and assistance in the redevelopment of commercial corridors within the City of Columbia. This program aims to improve the appearance of businesses along the corridors throughout the city that are significantly deteriorated.

TECHNICAL ASSISTANCE, EDUCATION & ADVOCACY

Provides business development assistance and courses for start-ups and existing businesses looking to expand and grow on various topics including: marketing, use of social media, business plan development, finances, legal issues, and more.

CONTRACTOR & SUPPLIER DIVERSITY

Provides training and support for city initiatives designed to increase local contractor's capacity to compete for government contracts and other procurement opportunities. We are also responsible for the implementation of the City's Disparity Study Goals and Objectives. Programs include: Mentor Protégé; Local Business Enterprise; and Columbia Disadvantage Business Enterprise. The City of Columbia currently has a 15% citywide DBE goal, determined by the City Manager, to ensure minority/women owned businesses are being utilized by all city departments.
